Seats Available for counseling*: - for **BHMS** 1) Dr. Abhin Chandra Homoeopathic Medical College & Hospital, Bhubaneswar (Govt.): 25 (01 seat reserved for Govt. of India nominee); 2) Biju Pattanaik Homoeopathic Medical College & Hospital, Berhampur (Govt.): 25; 3) Utkalmani Homoeopathic Medical College & Hospital, Rourkela (Govt.): 25; 4) Odisha Medical College of Homoeopathy & Research, Sambalpur (Govt.): 25; 5) Cuttack Homoeopathic Medical College & Hospital, Cuttack (Private) :30; & 6) Mayurbhanj Homoeopathic Medical College & Hospital, Baripada (Private): 30 and for **BAMS** 1) Gopabandhu Ayurveda Mahavidyalaya, Puri (Govt.): 30 (01 seat reserved for Govt. of India nominee); 2) Govt. Ayurveda College, Bolangir (Govt.): 30; 3) K.A.T.S. Ayurveda College, Ankuspur, Ganjam (Govt.): 30; 4) S.S.N. Ayurveda College and Research Institute, Paikmal, Dist : Bargarh (Private): 50.

* The seats mentioned above include General, SC, ST, GC, PH/PC, Military/ES category.

Note: Duration of Courses is 5 & 1/2 years including one year compulsory rotatory internship.

2. Reservation Policy:

The reservation of seats shall be as indicated below.

2.1.1 22.50% for Scheduled Tribe candidates

2.1.2 16.25% for Scheduled Caste candidates

2.1.3 05% for Children of Green Card holders within concerned category.

2.1.4 03% for Children of Military / Ex-servicemen within concerned category.

Candidates claiming reservation under Military / Ex-Serviceman reserved category shall furnish a certificate in the prescribed format provided in Appendix-XI (mentioned below) at the time of document verification. The allotment under this category will be done based on the prioritization obtained from Rajya Saink Board. **The candidate must attend the Ex-servicemen Board at Rajya Saink Board, Bhubaneswar on the scheduled date and time.** The decision of this Board is final and binding.

2.1.5 03% for Physically Handicapped/Challenged candidates (as per C.C.I.M. guideline) within concerned category. Physically handicapped shall mean the person having Locomotory disability of lower limb only. Visually handicapped and hearing disabled shall not be eligible. Further the locomotory disabled involving the lower limb is permissible to the following extent.

- (i) If it involves only one lower limb it should have a minimum of 40% and should not exceed 60%.
- (ii) If it involves both the lower limbs the total disability should not exceed 60% with a minimum of 40%.

For claiming reservation under this category **the candidate must get examined in the PH/PC Medical Board at SCB Medical College on the scheduled date and time. The decision of this Board will be final and binding.** They SHOULD NOT therefore, submit any medical certificate to the effect that they are physically Handicapped/Challenged during document verification of the counseling.

2.1.6 One seat each in Gopabandhu Ayurveda Mahavidyalaya, Puri (for B.A.M.S. Course) and Dr. Abhin Chandra Homoeopathic Medical College & Hospital, Bhubaneswar (for B.H.M.S. Course) shall be kept reserved for the nominees of Government of India. If no candidate report for admission by the counseling date, the seat will be filled' up by the General candidate from the OJEE-2013 merit list.

2.1.7 Candidates belonging to reserved categories can also compete with general category candidates. A reserved category candidate figuring in the OJEE-2013 merit list for both reserved and general category may first exercise his / her option under reserved category. Candidate who foregoes option under reserved category may opt according to his / her merit position under general category, for admission at the time of counselling.

2.1.8 Unfilled seats reserved for S.T. or S.C. category shall be filled up by admission of either S.C. or S.T. student respectively as the case may be. Reserved seats if unfilled will be diverted to general category.

Candidates claiming seat under SC/ST reserved category shall furnish SC/ST certificate from the Tahasildar of the place of birth in Odisha at the time of document verification in the format given in this brochure (Appendix – III) [Ref: http://www.odishajee.com/counselling_brochure_ojee_2013.pdf].

NOTE : Scheduled Caste/Scheduled Tribe persons who have migrated from their state of origin to another state for the purpose of seeking education, employment etc., will be deemed to be scheduled caste/ tribe of the state of their origin and will be entitled to derive benefits from the state of origin and not from the state to which they have migrated. (Vide Govt. India Letter No. BC/160 14.1.82 SC & BCD/ dated 22nd Feb, 1985). Thus, SC/ST candidates from Odisha who are staying outside the State have to produce SC/ST certificate from the competent authority of Odisha State during document verification.

2.1.9 Seats reserved under all other category like PH/PC, GC, Military/Ex-Servicemen etc will be filled up by general category candidates in case the same are not filled up from the reserved category.

For BAMS and BHMS Courses the reservation is as given below:

Scheduled Tribe	22.50%
Scheduled Caste	16.25%
Green Card	5%
Military / Ex-Servicemen	3%
Physically Handicapped/Challenged	3%

Note: All the above mentioned reservations for admission to BHMS & BAMS courses are applicable to permanent natives of Odisha State only and the candidates must produce permanent residence certificate in Appendix – I from Odisha State during document verification.

3. Eligibility for Admission:

3.1 Eligibility in the Qualifying Examination:

3.1.1 General Category: Must have Passed 10+2 Science or any other equivalent examination subject to production of proof of equivalency from competent authority with Physics, Chemistry and Biology as subjects. The candidate should have passed individual subject and must have obtained at least 50% marks in the above subjects taken together.

3.1.2 SC/ST Category: Must have Passed 10+2 Science or any other equivalent examination subject to production of proof of equivalency from competent authority with Physics, Chemistry and Biology as subjects. The candidate should have passed individual subject and must have obtained at least 40% marks in the above subjects taken together.

3.2 Age: The candidate must be within the age group of 17 years to 25 years of age as on 31st December, 2013. Upper age limit is relaxed by 3 years for S.C. / S. T. candidates only. The candidate has to submit H.S.C. or equivalent certificate in support of age.

3.3 Nativity:

Candidate applying for admission must belong to any of the following categories and furnish relevant certificate to that effect:

3.3.1 Permanent resident of Odisha (as defined in Govt. of Odisha, Home Department Resolution No. 38 (Reforms), dated 18th January, 1949) and prosecuting their studies in Odisha shall furnish Resident certificate from the concerned Tahasildar, obtained within a period of 6 (six) months.

3.3.2 Candidates claiming residence in Odisha but prosecuting studies in other States shall furnish Nativity Certificates from the **Revenue Officer not below the rank of Tahasildar** of their native places. Such candidates must have Oriya as M.I.L. in 7th Pass or equivalent examination and shall submit certificate from competent authority.

3.3.3 Oriyas belonging to outlying Oriya speaking tracts (as defined by Govt. of Odisha in erstwhile P & S Department Resolution No. 13411/Gen. Dated 8th August, 1969). Such candidates must have Oriya as M.I.L. in 7th Pass or equivalent examination and furnish the certificates of authenticity of their Oriya origin from an officer not below the rank of Collector and a certificate of having passed Oriya as M.I.L. in 7th pass or equivalent examination from the competent authority.

3.3.4 Sons, daughters and spouses of permanent employees of Govt. of Odisha / Members of All India Services (Odisha cadre) serving within or outside Odisha at the time of application / permanent employees of Govt. of India serving in Odisha at the time of application / Permanent employees of Govt. of India / Govt. of Odisha Undertakings & located in Odisha and serving in Odisha at the time of application, who have passed +2 Science or equivalent examination from any institution located within Odisha / Permanent employees of Universities of Odisha / Defence personnel posted in Odisha are eligible for admission (Such claim should be supported by certificate of service of parent or spouse from the competent authority).

4. Certificate of Reserve category:

4.1 Candidate claiming admission under Schedule Caste / Schedule Tribe shall furnish Caste Certificate from the Revenue Officer not below the rank of Tahasildar in Appendix – III [Ref: http://www.odishajee.com/counselling_brochure_ojee_2013.pdf].

4.2 Candidate claiming admission under Green Card category shall furnish Green Card from competent Medical authority.

4.3 Candidate claiming admission under Military / Ex. Service Man category shall furnish Certificate from competent authority. The **Ex-serviceman candidate must attend Ex-servicemen Board at Rajya Saink Board, Bhubaneswar in the scheduled date and time.** The decision of this Board is final and binding.

4.4 Candidate claiming admission under P.H. / P.C. category **must get examined in the PH/PC Medical Board at SCB Medical College in the scheduled date and time. The decision of this Board will be final and binding.** They SHOULD NOT therefore, submit any medical certificate to the effect that they are Physically Handicapped/Challenged during document verification of the counseling.

5. Document Verification:

The original certificates and mark sheets along with two sets (set 1 and set 2) of attested true copies of certificates and mark sheets as per eligibility of the candidate MUST be produced during document verification as detailed below.

10. Original Certificate of Employment of Candidate's parent / Spouse (Appendix – II) Employer: Govt. of Odisha / Govt. of India / Govt. of India Undertakings and / Govt. of Odisha Undertakings located in Odisha at the time of application.
11. Original SC / ST certificate by birth (Appendix – III).
12. Original Certificate of Military / Ex-serviceman (Appendix – XI).
13. Original Certificate in support of Outlying Oriya Speaking Tract (OL) (Appendix – XII).
14. Attested true copy of Green Card if claiming seat under GC category.
15. Other relevant documents, if any

SET 2 (To be returned to the candidates after verification at the Counseling Centre)

NOTE: The candidate must keep Photocopies of all the original documents submitted at the time of document verification.

Vital points

- i. The candidate must have valid OJEE-2013 rank card to participate in this counselling.
- ii. All the candidates have to report to the counselling center as per their OJEE 2013 rank and schedule mentioned above.
- iii. All the candidates have to verify their documents during counselling as per the schedule given above.
- iv. All the candidates appearing for document verification in this counseling have to deposit the non refundable counseling fee of Rs. 450/- in the form of DD in favour of "OJEE-2013" payable at Bhubaneswar.
- v. All the candidates have to pay non refundable University Registration Fee Rs.5,000/- in the form of DD in favour of "OJEE-2013" payable at Bhubaneswar during document verification.
- vi. If a candidate does not report during scheduled date and time of reporting for counseling, he/she will be treated as absentee and will not be permitted to participate in the counselling subsequently under any circumstances.
