ELIGIBILITY

(A) For admission to First Year Bachelor programme in :

Engineering/Technology : Passed or appearing in 2013, 10+2 examination of CHSE, Odisha or equivalent with Physics and Mathematics as compulsory subjects along with one of the subjects from Chemistry / Biotechnology / Biology/ Technical Vocational Subject / Electronics / Computer Science / Information Technology/ Geology / Statistics. The candidate should have passed individual subject and must have obtained at least 45% marks (40% in case of candidate belonging to SC/ST category) in the above subjects taken together.

Architecture : Passed or appearing in 2013, 10+2 examination of CHSE, Odisha or equivalent with Physics and Mathematics as compulsory subjects along with one of the subjects from Chemistry / Engineering Drawing / Computer Science / Biology / Technical Vocational Subject. The candidate should have passed individual subject and must have obtained at least 45% (40% in case of candidate belonging to SC/ST category) marks in the above subjects taken together.

Admission into the above 5-year B.Arch. Degree course is subjected to passing NATA conducted by the Council of Architecture. The minimum passing score for NATA is 40% for all categories of candidates. NATA shall be a prerequisite for admission into B.Arch course, but the ranking shall be done on the basis of OJEE-2013 test. Admission to the course will be done on the basis of OJEE-2013 rank.

Pharmacy : Passed or appearing in 2013, 10+2 examination of CHSE, Odisha or equivalent with Physics and Chemistry as compulsory subjects along with one of the subjects from Mathematics / Biotechnology / Biology / Technical Vocational Subject. The candidate should have passed individual subject and must have obtained at least 45% marks (40% in case of candidate belonging to SC/ST category) in the above subjects taken together.

BHMS/BAMS : Passed in 10+2 Science or appearing in 2013 examination of CHSE, Odisha or equivalent, with Physics, Chemistry & Biology (Botany and Zoology) with at least 50% marks in aggregate (Physics, Chemistry & Biology taken together) for general category candidates and 40% marks in aggregate for SC/ST candidates.

AGE (for BHMS and BAMS only) : The lower age shall be 17 years as on December 31, 2013. The upper age shall be 25 years as on December 31, 2013. The upper age limit may be relaxed by three years for SC/ST candidates. The candidates have to submit H.S.C. or equivalent certificate in support of age during certificate verification at the time of counselling.

(B) For admission to First Year Masters programme in

Computer Application (MCA) : Passed or appearing in 2013, for the Bachelor's Degree examination of minimum three years duration in any discipline from any University of Odisha or from a recognized University as defined by UGC and must have passed in Mathematics at 10+2 level or at Graduate Level. Business Mathematics at +2 level are not permitted. The candidate should have obtained at least 50% (45% in case of candidate belonging to SC/ST category) at the qualifying Examination.

Business Administration (MBA)/ PGDM : Passed or appearing in 2013, for the Bachelor's Degree examination of minimum three years duration in any discipline or Bachelor's Degree in Engineering / Technology / Pharmacy from any University of Odisha or from a recognized University as defined by UGC/AICTE.

The candidate should have obtained at least 50% marks (45% in case of candidate belonging to SC/ST category) at the qualifying examination.

PGCM : Passed or appearing in 2013, for the Bachelor's Degree examination of minimum three years duration in any discipline or Bachelor's Degree in Engineering / Technology / Pharmacy from any University of Odisha or from a recognized University as defined by UGC/AICTE.

PGDM (Executive) : Passed the Bachelor's Degree examination of minimum three years duration in any discipline or Bachelor's Degree in Engineering / Technology / Pharmacy from any University of Odisha or from a recognized University as defined by UGC and a minimum of 5 years relevant managerial / supervisory experience.

The candidate should have obtained at least 50% marks (45% in case of candidate belonging to SC/ST category) at the qualifying examination.

PGAT (M.Tech/M.Tech(PT)/M.Arch/M.Pharm) : Passed or appearing in 2013, Bachelor's Degree of examination in the relevant discipline/field/program-in Engineering or Technology / Pharmacy / Architecture from any University of Odisha or from an AICTE approved Institute or from a recognized University as defined by UGC. For M.Tech (Part Time) the candidate should have minimum of Two years full time work experience in a registered Firm / Company / Industry / Educational and / Government, Autonomous Organisations in the relevant field in which admission is sought.

The candidate should have obtained at least 50% marks (45% in case of candidate belonging to SC/ST category) at the qualifying examination. For M.Tech (Part Time) the candidate should have passed the qualifying examination.

(C) For admission to Dual Degree course :

MCA-Dual Degree : Passed or appearing in 2013, 10+2 examination of CHSE, Odisha or equivalent with Physics and Mathematics as compulsory subjects along with one of the subjects from Chemistry / Biotechnology / Biology / Technical Vocational subject. The candidate should have passed individual subject and must have obtained at least 45% marks (40% in case of candidate belonging to SC/ST category) in the above subjects taken together.

MAM : Passed or appearing in 2013, 10+2 examination of CHSE, Odisha or equivalent. The candidate should have passed all the individual subject and must have obtained at least 45% marks (40% in case of candidate belonging to SC/ST category) in all the subjects taken together.

(D) For admission to Second Year Engineering/Technology/Architecture/Pharmacy/MCA under Lateral Entry :

Engineering/Technology/Architecture(LE) : Passed or appearing in 2013, in three year diploma examination (two year in case of Lateral entry Diploma) in Engineering from State Council of Technical Education and Training (SCTE&VT), Odisha or from an AICTE approved Institute / from a recognized University as defined by UGC with at least 45% marks (40% in case of candidates belonging to SC/ST category) in Engineering/Technology/Architecture in the qualifying examination.

Pharmacy(LE) : Passed or appearing in 2013 in diploma examination in two years diploma course after XII standard in Pharmacy with minimum 45% (40% in case of candidate belong to SC / ST category) of marks in aggregate from Odisha State Board of Pharmacy (OSBP) or SCTE&VT or from an AICTE approved Institution / from a recognized University as defined by UGC for direct admission to the third semester degree courses.

MCA(LE) : Passed or appearing in 2013, for the Bachelor's Degree examination of minimum three years duration in BCA, B. Sc (IT/ Computer Science) from any University of Odisha or from a recognized University as defined by UGC and must have passed in Mathematics as a course at 10+2 level or at Graduate Level. Business Mathematics at +2 level are not permitted. The candidate should have obtained at least 50% (45% in case of candidate belonging to SC/ST category) at the qualifying Examination.

(E) For admission to Second year Degree courses in Engineering/Technology under Lateral Entry for B. Sc. / +3 Sc. students :

Passed or appearing in 2013, for the Bachelor's Degree examination of three years duration in Science from any University of Odisha or from a recognized University as defined by UGC, with at least 45% marks (40% in case of candidates belonging to ST/SC category) and must have passed XII standard with Mathematics as a subject.

RESERVATION : The reservation of seats in different colleges under various categories will be as per the policy of the Government of Odisha. The percentage of seats to be reserved for different categories is subject to change and the decision of the State Government as on the date of counselling will be applicable.

OUTSIDE STATE CANDIDATE : Outside State candidates are not eligible for admission in Government Colleges but they are eligible for admission to private colleges as per Odisha Government rule.
